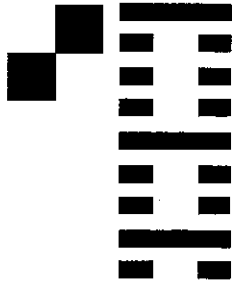


Official Ballot Special Primary for Partisan Office September 1, 2015



Notice to voters: This ballot may be invalid unless initialed by 2 election inspectors.
If used as an absentee ballot, the ballot must bear the initials of the municipal clerk or deputy clerk.

IMPORTANT: USE BLUE OR BLACK INK ONLY.

Instructions to Voters

Do not make a mistake on your ballot. If you have a question, see an election inspector. (Absentee voters: Contact the municipal clerk.)

Use a party primary.

Vote in only ONE party at a primary.

Choose one party, votes cast in that party will be counted. Votes cast in any other party will not be counted.

Do not choose a party, and you vote for more than one party, no votes will be counted.

Vote for a candidate in your party primary.

Write a name on the ballot, next to the arrow next to the name.

Write a name that is not on the ballot next to the arrow next to the name on the line "write-in," and complete the line next to the name like this.

Vote for ONE candidate in only ONE party.

Write the arrow next to your party choice like this: **Choose one.**

- Libertarian
- Wisconsin Green
